4 First Aid Measures

Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, hold eyelids open and rinse with water for at least 15 minutes. Seek medical attention if symptoms occur.

Ingestion:

If swallowed, do not induce vomiting. If vomiting occurs spontaneously, keep head below hips to prevent aspiration. Do not give anything by mouth to an unconscious person. Seek immediate medical attention.

Medical Attention and Special Treatment:

In cases of poisoning atropine sulphate should be given at 5 - 10 minute intervals until dryness of the mouth occurs.

Atropine should NOT be given to patients suffering from cyanosis.

In cases of severe poisoning administer pralidoxime.

Suitable Extinguishing Media: Water spray, foam, dry chemical, sand or carbon dioxide.

Specific Hazards Arising from the Chemical:

Hazardous combustion products include oxides of carbon, nitrogen and phosphorus and hydrogen cyanide.

Product is not flammable, but dust may form explosive dust cloud in air.

Containers close to fire should be removed if safe to do so. Use water spray to cool fire exposed containers.

Special Protective Equipment and Precautions for Fire Fighters:

When fighting a major fire wear self-contained breathing apparatus and protective equipment.

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear Australia approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust. Work from the up-wind side of the spill.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Clean the spill area with an aqueous detergent and small amounts of water and then spread hydrated lime over the effected area.

7 Handling and Storage

Precautions for Safe Handling:

Take precautions to prevent formation of explosive dust mixtures.

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust.
