Active Constituent: 800g/kg NAPHTHALOPHOS  
(an anticholinesterase compound)



## MOXIMAX PLUS SILENIUM: ORAL DRENCH

For the treatment and control of moxidectin sensitive internal parasites.

Active Constituent: 1mg/ml Moxidectin, 0.5mg/ml Selenium



## TRIO: COMBINATION DRENCH

For the control and treatment of internal parasites.

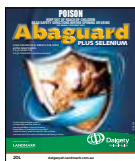
Active Constituents: Abamectin 1 g/L, Levamisole 33.9 g/L, Oxfendazole 22.7 g/L, Selenium 0.5 g/L



## COMBINATOR LV PLUS SILENIUM: ORAL ANTHELMINTIC

For the control of roundworms in sheep and lambs and as an aid in controlling selenium deficiencies in sheep and lambs.

Active Constituents: 67.8 g/L LEVAMISOLE (as Levamisole Hydrochloride), 50 g/L FENBENDAZOLE 1 g/L SILENIUM (as Sodium Selenate)



## ABAGUARD + SILENIUM: ORAL DRENCH

For the treatment and control of abamectin sensitive strains of internal parasites.

Active Constituents: 0.8 g/L Abamectin, 0.4 g/L SILENIUM (as sodium selenate)



## MOXIMAX -LONG ACTING INJECTION

For the treatment and control of roundworms, nasal bot and itchmite in sheep.

Active Constituents: 20g/L Moxidectin
